The Bloomfield City Council met in regular session at 7:00 pm at the Bloomfield Public Library with the following members present:

Mayor Miller called the meeting to order and welcomed those present. Everyone stood and recited the Pledge of Allegiance.

Motion by Bohi, second by Walton to approve agenda.

AYE: Spargur, Husted, Bohi, Walton, Howard NAY: None Motion carried.

The Mayor announced that this was the time and place for the public hearing and meeting on the matter of the authorization of a Loan and Disbursement Agreement by and between the City and the Iowa Finance Authority, and the issuance to the Iowa Finance Authority of not to exceed \$520,000 Sewer Revenue Capital Loan Notes to evidence the obligations of the City under said Loan and Disbursement Agreement, in order to provide funds to pay costs of acquisition, construction, reconstruction, extending, remodeling, improving, repairing and equipping all or part of the Municipal Sewer Utility, including construction of sidewalk improvements, including permeable paver sidewalks and bioretention cells, for Jefferson Street from Madison Street to US 63 and Madison Street from Franklin Street to Jefferson Street, and construction of the Davis Street Bioretention Project, each a water resource restoration project within or without the corporate limits of the City, and that notice of the proposed action by the City Council to institute proceedings for the authorization of the Loan and Disbursement Agreement and the issuance of the Notes had been published pursuant to the provisions of Sections 384.24A and 384.83, as amended.

Motion by Bohi, second by Husted to open the Public Hearing.

The Mayor then asked the Clerk whether any written objections had been filed by any City resident or property owner to the proposal. The City Clerk advised the Mayor and the City Council that no (zero) written objections had been filed. The Mayor then called for oral objections to the proposal and no (zero) were made. Whereupon, the Mayor declared the time for receiving oral and written objections to be closed.

Motion by Bohi, second by Walton to close the Public Hearing.

Motion by Howard, second by Bohi to approve Resolution authorizing a Loan and Disbursement Agreement and the issuance of Notes not to exceed \$520,000 Sewer Revenue Capital Loan Notes to evidence the obligation of the City of Bloomfield, State of Iowa.

Motion by Walton, second by Howard to approve Resolution Instituting Proceedings to Take Additional Action for the Issuance of not to exceed \$520,000 Sewer Revenue Capital Loan Notes.

Motion by Husted, second by Spargur to approve Resolution approving and authorizing a form of Loan and Disbursement Agreement by and between the City of Bloomfield, Iowa, and the Iowa Finance Authority, and authorizing and providing for the issuance and securing the payment of \$520,000 Sewer Revenue Capital Loan Notes, Series 2024, of the City of Bloomfield, Iowa, under the provisions of the Code of Iowa, and providing for a method of payment of said Notes.

Motion by Howard, second by Spargur to approve Resolution approving and authorizing Amendment to Loan and Disbursement Agreement by and between the City of Bloomfield and the Iowa Finance Authority, and authorizing and providing for the reissuance of the \$8,004,000 Sewer Revenue Capital Loan Note, Series 2020 (Rate Reset for Sponsored Project).


